The Gilbert School has been able to offer a water sports holiday to its students for many years. We are pleased to be able to offer this trip again during the summer of 2011.

The trip details are as follows:

Course: Mediterranean Watersports (PGL Overseas Adventures)

Centre: La Fosca

Country: Spain

Depart from the UK: Sunday 31st July 2011

Return to the UK: Monday 8th August 2011

Cost per child: £639.00

Mode of travel: Coach

Included in the above cost is transportation, accommodation, food, activities, evening entertainment, and insurance. Activities include windsurfing, catamarans, sit on kayaks, laser boats, banana boats, and a day at a local water park.

This trip will be run by at least 4 school staff members, in conjunction with the specialist schools operator, PGL Travel Ltd. The Gilbert School has travelled with this company for many years, and have always had a positive experience with them.

In order to reserve a place on the trip, a non-refundable deposit of £50 is due by Wednesday 28th April.
